LANEWAY TREATMENT TRIAL

FACT SHEET: STAGE 3 PART1

In early 2019, Council began trialling treatments in 11 laneways across three Palmerston suburbs to assess if the measures taken will help discourage anti-social behaviour in these areas.

Following community feedback, Council is proposing to modify the treatments by adding either temporary full-time or night-time closures to seven of the laneways included in the trial.
