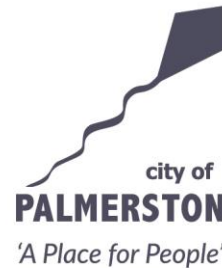


LANEWAY APPLICATION

Part Time Closure or Night closure

Typically involves daily closing of a laneway with locked gates typically between the hours of 9:00pm and 6:30am with the duration of the daily closing as determined by Council.

The time of closure will be assessed to suit the circumstances of the laneway.

Temporary Full Time Closure

The closure of the laneway with locked gates with the duration of closure as determined by Council in accordance with the policy. Minimum closure of 12 months, which will reopen after the 12-month temporary closure period.

Permanent Closure (only considered if the intent is to purchase the laneway)

The closing of a laneway by the creation of a new lot that is defined by the boundaries of the abutting properties with the intent to dispose of the lot and consolidate into abutting properties.

Amendment of a current Laneway treatment

The reopening of a laneway, change of treatment type, or adjustment of closure hours.


4. ACKNOWLEDGMENT THAT THE WHOLE OF THE CLOSED LANEWAY WILL BE SUBDIVIDED AND AMALGAMATED WITH ABUTTING PROPERTIES

Where it is not possible to have all property owners sign this section, separate pages may be attached to this form with the respective owner/s signature provided the wording of the acknowledgement is included on the page/s.

The following listed owners acknowledge that:

- (a) Where a laneway is bounded by two (2) properties at least one property owner will be required to pay for the value of the acquired land and amalgamate that portion with their property.
- (b) Where the laneway is bounded by four (4) properties at least one property owner on each street frontage will be required to pay for the value of the acquired land and amalgamate that portion with their property.
- (c) Payment will not be required prior to the completion of the permanent closure.
- (d) The amount to be paid will be calculated in accordance with the methodology detailed in the Laneway Management Policy.
- (e) A Contract of Sale will be entered into with the respective property owners upon completion of the process to permanently close the laneway and upon the agreed layout for the subdivision of the land.
- (f) A City of Palmerston invoice will be issued to each of the respective property owners and payment required prior to submitting the documentation to the Land Titles Office for processing.
