**IMPORTANT INFORMATION** 

- 1. When upon a public place the animal is to be under the control of a competent person, and is a requirement that such be retained by leash, cord, chain or similar device.
- 2. It is advisable that the animal wears its current identification tag issued by City of Palmerston as for example this will assist in its return if it is lost.
- If the owner of the dog has not reached the age of 17 then a parent or guardian must sign this form as a joint owner.
  A person who is registering the animal on behalf of its owner is required to show that authority in writing.
- 4. A person who is registering the animal on benair of its owner is required to show that authority in writing. This is to be attached to the application.

### DECLARATION

I declare that the particulars of my application to be true. I understand that it is an offence for a dog to: Be at large, to attack or menace a person or another animal or to cause a nuisance by continually barking. Registration of your dog can be cancelled at any time if Council believes, on reasonable grounds, that the dog is destructive, dangerous, savage or a threat to the safety of the community. Please note that it is an offence to make a false statement or declaration.
