Competition (you must have pre registered for this)

Check in from 4:30pm until 5:00, registered participants can collect their judging number from Geekfest Cosplay Desk. Please keep it with you or pin this number to your outfit until the conclusion of the judging.

Make your way to the Judging area in the Arena (Recreation Centre Stadium). You will be called up by your assigned judging number. Judges will review your entry before you make an appearance on the stage runway.

Judging Criteria

Costumes can be purchased or hired however points will be allocated for:

Judging Area	Details	Percentage of
Workmanship	How has the outfit been modified or created? What materials have been used?	Juniors – 20% Youth - 40% Adults – 60%
Embodiment of Character	Voices, motions and phrases	Juniors – 20% Youth - 20% Adults – 20%
Effort	Effort undertaken to complete the overall look of the character using make-up, hair, wigs or additional props	Juniors – 60% Youth - 40% Adults – 20%

Terms & Conditions of Entry

- Contestants are eligible to enter and win one category only.
- Participants must be pre-registered to be eligible for prize money. Registrations will not be accepted at the event.
- Contestants must meet the criteria of the judging areas to enter.
- Prize money will be posted by bank deposit to the name and address listed on the registration form.

General Guide

1. As this is a family friendly event – no nudity is permitted. To avoid any disappointment, please ensure your costume attire is appropriate for a general (G) audience.
2. For safety reasons, footwear must always be worn in the event zone.
3. No mock or play fighting is permitted outside of pre-designated displays and performances.
4. Please be considerate of other attendees when posing for photos and take care not to obstruct pathways and entrances.
5. Kindly seek permission of any fellow attendees, before taking any photos of them.

Weapons & Props Guide

6. All weapons and props must be presented to Geekfest Top End staff or security on entry for inspection.
7. If a weapon or prop is judged to be potentially harmful/dangerous for general use around the event, it must be removed from the event space immediately. Staff & security reserve the right to re-assess props during the event.
8. No real firearms or replica firearms which could be easily confused with the real thing are permitted at the event.
9. When travelling to and from Geekfest Top End, if carrying props which may cause alarm to members of the general public, please consider covering props during your journey.
10. Empty water guns/nerf guns without ammunition are allowed, no use of any projectile weaponry is permitted at the event.
11. Skates, roller-blades, stake boards or any other moving items will not be allowed into the venue.

We look forward to seeing the creativity and effort Top End cosplayers put into their costumes.

Terms & Conditions of entry

1. These Terms & Conditions incorporate the Schedule. If there is any inconsistency between the Schedule and these Terms & Conditions, the Terms & Conditions prevail.
2. Participation in this Competition is deemed acceptance of these Terms of Entry. Entrants not complying with these Terms of entry are ineligible entrants and the Promoter reserves its absolute right to disqualify any entrant from the Competition if any entries do not comply with the Terms and Conditions.
3. Entry is open to any person who meets the requirements of these Terms and Conditions.
4. The Competition will be conducted during the Competition period as stated in the Schedule.
5. The Prize/s are as specified in the Schedule.
6. The total prize pool is as specified in Schedule.
7. Any prize is valued in Australian dollars unless expressly stated to the contrary.
8. All vouchers are valid until the expiry date stated on the voucher as provided by the supplier.
9. Entrants agree to comply with any terms and conditions stated on the voucher supplied by the supplier
10. Neither the Promoter nor the voucher provider is liable for any voucher that has been stolen, forged, lost, damaged or tampered with in any way.
11. Entrants are advised that tax implications may arise from their prize winnings, and they should seek independent financial advice prior to acceptance of their prize(s). The Promoter accepts no responsibility for any tax implications that may arise from accepting a prize. Notification to winners will be deemed to have occurred on the later of the time the winner receives actual notification from the Promoter or 48 hours after the promoter uploaded the notification. The notification will include details about how the prize(s) can be claimed.
17. The Promoter takes no responsibility where it is unable to contact prize winners who have not provided correct or complete contact details. If an entrant's contact details change during the Competition period, it is the entrant's responsibility to notify the Promoter. A request to modify any entry information should be directed to Promoter.
18. It is a condition of accepting any prize that the winner must comply with all the conditions of use of the prize and the prize supplier's requirements. Each prize must be taken as stated and no compensation will be payable if a winner is unable to use the prize as stated.
19. The winner(s) name will be published in accordance with the public announcement of winners' section of the Schedule (if applicable).

21. To the full extent permitted by law, the Promoter excludes all warranties, representations or guarantees (Warranties) regarding the Competition and any prizes, including any Warranties which may have been made in the course of advertising or promoting the Competition. 23. Without limiting any of the foregoing, in no circumstances will an entrant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.
24. The Promoter and its associated agencies and companies will not be liable for any delay, damage, or loss in transit of prizes.
25. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Competition at any time without giving reasons and without liability to any entrants, subject to any written directions from a regulatory authority. Without limiting this the Promoter reserves the right to verify the validity of entries, prize claims and entrants

In the event that a winner breaches these Terms of entry, the winner will forfeit the prize in whole and no substitute will be offered. Verification is at the discretion of the Promoter, whose decision is final. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

26. Prizes, or any unused portion of a prize, are not transferable or exchangeable and cannot be taken as cash, subject to any written directions from a regulatory authority. Where a prize is unavailable for any reason, the Promoter may substitute the prize for another item of equal or higher value subject to any written directions from a regulatory authority. The Promoter accepts no responsibility for any variation in prize value (including between advertising of the Competition and receipt of the prize).
27. The Promoter has no obligation to credit you as the author of any content submitted and may otherwise do any acts or omissions which would otherwise constitute an infringement of any moral rights you may have as an author of content.
29. Entrants consent to the Promoter using the personal information provided in connection with this Competition for the purposes of facilitating the conduct of the Competition and awarding any prizes, including to third parties involved in the Competition and any relevant authorities. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter including third parties may, for an indefinite period, unless otherwise advised, use the private information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant.
30. The collection and disclosure of personal information provided in connection with this Competition will be handled in accordance with the Promoter's Privacy statement which adheres to the Privacy Act 1988 (Cth) and Australian Privacy Principles.
31. The Competition and these Terms of entry will be governed by the law of the Northern Territory. Entrants accept the exclusive jurisdiction of courts and tribunals of the Northern Territory in connection with disputes concerning the Competition.
32. Social media platforms which may include but not be limited to Facebook, YouTube, Instagram, TikTok, or Snapchat may be used to advertise or promote the Competition. By entering the Competition, entrants agree that the Competition is in no way sponsored, endorsed or administered by, or associated with Facebook, YouTube, Instagram, TikTok or Snapchat; and to release Facebook, YouTube, Instagram, TikTok, or Snapchat from all liability in relation to this Competition.
