(Published on the City of Palmerston Website).</li> <li>Eligibility: The Power Point Party is open to youth aged 15 to 25. All entrants under 18 must make sure they have their parent /guardians consent to enter.</li> <li>Presentation Categories: There are three categories for presentations: Punniest (most entertaining), Purposeful (most useful), and Powerful (most engaging). Participants may only submit one presentation per category.</li> <li>Presentation Format: All presentations must be in PowerPoint or Canva Presentation format and should not exceed 5 minutes in length.</li> <li>Original Content: All presentations must be original content and cannot have been previously published or presented.</li> </ul>

<ul> <li>3. Powerful:</li> <li>Engaging and captivating introduction</li> <li>Effective use of visuals and multimedia</li> <li>Delivery and speaking skills</li> <li>Ability to maintain audience's interest throughout the presentation</li> </ul>

- 1. These Terms & Conditions incorporate the Schedule. If there is any inconsistency between the Schedule and these Terms & Conditions, the Terms & Conditions prevail.
- 2. Participation in this Competition is deemed acceptance of these Terms of Entry. Entrants not complying with these Terms of entry are ineligible entrants and the Promoter reserves its absolute right to disqualify any entrant from the Competition if any entries do not comply with the Terms and Conditions.
- 3. Entry is open to any person who meets the requirements of these Terms and Conditions.
- 4. The Competition will be conducted during the Competition period as stated in the Schedule.
- 5. The Prize/s are as specified in the Schedule.
- 6. The total prize pool is as specified in Schedule.
- 7. Any prize is valued in Australian dollars unless expressly stated to the contrary.
