(Published on the City of Palmerston Website).</li> <li>• Eligibility: The Power Point Party is open to youth aged 15 to 25. All entrants under 18 must make sure they have their parent /guardians consent to enter.</li> <li>• Presentation Categories: There are three categories for presentations: Punniest (most entertaining), Purposeful (most useful), and Powerful (most engaging). Participants may only submit one presentation per category.</li> <li>• Presentation Format: All presentations must be in PowerPoint or Canva Presentation format and should not exceed 5 minutes in length.</li> <li>• Original Content: All presentations must be original content and cannot have been previously published or presented.</li> </ul>

# Power Point Party

- Appropriate Content: All presentations must be appropriate for a general audience. Any presentation containing offensive or inappropriate material will be disqualified.
- The total score for each category will be out of 30 points.
- Deadline: The deadline for submission of presentations is 9 April 2023.
- Judging: A panel of GG Social judges will evaluate all submissions and select a winner for each category. The judges' decision is final.
- Judges will base their decision on the following:
  1. Punniest:
    - Originality and creativity of puns
    - Quality of humour and wit
    - Appropriateness of puns for the chosen topic
    - Delivery and presentation skills
  2. Purposeful:
    - Relevance and depth of research
    - Clarity and simplicity of message
    - Practicality and applicability of the ideas presented
    - Evidence and support for the argument
  3. Powerful:
    - Engaging and captivating introduction
    - Effective use of visuals and multimedia
    - Delivery and speaking skills
    - Ability to maintain audience's interest throughout the presentation
- Prizes: Winners of each category will receive a cash prize of \$150.
- Sharing of presentations: By submitting a presentation, participants agree to allow their presentation to be shared on social media and other platforms for promotional purposes.
- Personal information: By participating in the Power Point Party, participants agree to the collection, use, and disclosure of their personal information for the purposes of the Power Point Party only.
- Liability: Participants agree to hold the organisers of the Power Point Party harmless from any liability or damages resulting from their participation in the Power Point Party.
- Changes: The organisers of the Power Point Party reserve the right to modify or cancel the Power Point Party at any time.
- By participating in the Power Point Party, participants agree to abide by these Terms and Conditions. Failure to comply with these Terms and Conditions may result in disqualification.

## Terms & Conditions of entry

1. These Terms & Conditions incorporate the Schedule. If there is any inconsistency between the Schedule and these Terms & Conditions, the Terms & Conditions prevail.
2. Participation in this Competition is deemed acceptance of these Terms of Entry. Entrants not complying with these Terms of entry are ineligible entrants and the Promoter reserves its absolute right to disqualify any entrant from the Competition if any entries do not comply with the Terms and Conditions.
3. Entry is open to any person who meets the requirements of these Terms and Conditions.
4. The Competition will be conducted during the Competition period as stated in the Schedule.
5. The Prize/s are as specified in the Schedule.
6. The total prize pool is as specified in Schedule.
7. Any prize is valued in Australian dollars unless expressly stated to the contrary.
8. Entrants are advised that tax implications may arise from their prize winnings, and they should seek independent financial advice prior to acceptance of their prize(s). The Promoter accepts no responsibility for any tax implications that may arise from accepting a prize. Entrants are responsible for any and all expenses that they incur in entering the competition and they will not be reimbursed regardless of whether or not they win the competition.

11. 18. To the full extent permitted by law, the Promoter excludes all warranties, representations or guarantees (Warranties) regarding the Competition and any prizes, including any Warranties which may have been made in the course of advertising or promoting the Competition. The conduct of the Competition or the supply of prizes may involve third parties, and the Promoter makes no Warranties and disclaims all liability in connection with any such third parties, their acts or omissions. By entering the Competition, an entrant releases and indemnifies the Promoter (including its officers, employees and agents) from and against all actions, penalties, liabilities, claims or demands the entrant may have against the Promoter or that the Promoter may incur for any loss or damage which is or may be suffered or sustained as a direct or indirect result of an entrant entering or participating in the Competition or winning or failing to win a prize, or using or permitting any other person to use the prize, except for any liability which cannot be excluded by law or which would cause any part of this clause to be void or unenforceable.
19. If despite the foregoing clause, the Promoter incurs a liability to an entrant under any law which implies a Warranty into these Terms of entry which cannot legally be excluded, the Promoter's liability in respect of the Competition is limited, in the Promoter's discretion, to either resupplying such goods or services as form part of the Competition, or paying the cost of resupplying those goods or services.
20. Without limiting any of the foregoing, in no circumstances will an entrant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.
21. The Promoter and its associated agencies and companies will not be liable for any delay, damage, or loss in transit of prizes.
22. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Competition at any time without giving reasons and without liability to any entrants, subject to any written directions from a regulatory authority. 27. The collection and disclosure of personal information provided in connection with this Competition will be handled in accordance with the Promoter's Privacy statement which adheres to the Privacy Act 1988 (Cth) and Australian Privacy Principles.
28. The Competition and these Terms of entry will be governed by the law of the Northern Territory. Entrants accept the exclusive jurisdiction of courts and tribunals of the Northern Territory in connection with disputes concerning the Competition.
