Competition Description	Rookie Cooks is an exciting cooking competition designed for young chefs to showcase their culinary skills and creativity in the kitchen. The competition is open to youths aged 15 to 25 who have a passion for cooking and a desire to learn and grow their culinary talents. The competition is divided into several rounds, starting with a preliminary round where participants join in a Master Class to learn the signature dish and dessert they must recreate. This will be followed be the cooking competition. A bonus round will offer contestants an extra challenge to obtain special ingredients to add to their dishes. Throughout the competition, contestants will have the opportunity to work with experienced chefs and industry professionals who will offer guidance, feedback, and advice. They will also receive valuable feedback from judges who will evaluate their dishes based on taste, presentation, and creativity. The goal of Rookie Cooks is to provide a platform for young chefs to develop their skills and confidence in the kitchen, while also fostering a sense of camaraderie and sportsmanship among contestants. Whether they go on to pursue careers in the culinary arts or simply enjoy cooking as a hobby, participants will walk away from the competition with new skills, knowledge, and friendships that will last a lifetime.

- 2. Participation in this Competition is deemed acceptance of these Terms of Entry. Entrants not complying with these Terms of entry are ineligible entrants and the Promoter reserves its absolute right to disqualify any entrant from the Competition if any entries do not comply with the Terms and Conditions.
- 3. Entry is open to any person who meets the requirements of these Terms and Conditions.
