Competition Description	<p>Rookie Cooks is an exciting cooking competition designed for young chefs to showcase their culinary skills and creativity in the kitchen. The competition is open to youths aged 15 to 25 who have a passion for cooking and a desire to learn and grow their culinary talents.</p> <p>The competition is divided into several rounds, starting with a preliminary round where participants join in a Master Class to learn the signature dish and dessert they must recreate. This will be followed by the cooking competition. A bonus round will offer contestants an extra challenge to obtain special ingredients to add to their dishes.</p> <p>Throughout the competition, contestants will have the opportunity to work with experienced chefs and industry professionals who will offer guidance, feedback, and advice. They will also receive valuable feedback from judges who will evaluate their dishes based on taste, presentation, and creativity.</p> <p>The goal of Rookie Cooks is to provide a platform for young chefs to develop their skills and confidence in the kitchen, while also fostering a sense of camaraderie and sportsmanship among contestants. Whether they go on to pursue careers in the culinary arts or simply enjoy cooking as a hobby, participants will walk away from the competition with new skills, knowledge, and friendships that will last a lifetime.</p> <p>So grab your mate and show us your skills!</p>

Rookie Cooks Competition

1. These Terms & Conditions incorporate the Schedule. If there is any inconsistency between the Schedule and these Terms & Conditions, the Terms & Conditions prevail.
2. Participation in this Competition is deemed acceptance of these Terms of Entry. Entrants not complying with these Terms of entry are ineligible entrants and the Promoter reserves its absolute right to disqualify any entrant from the Competition if any entries do not comply with the Terms and Conditions.
3. Entry is open to any person who meets the requirements of these Terms and Conditions.
4. The Competition will be conducted during the Competition period as stated in the Schedule.
5. The Prize/s are as specified in the Schedule.
6. The total prize pool is as specified in Schedule.
7. Any prize is valued in Australian dollars unless expressly stated to the contrary.
8. Entrants are advised that tax implications may arise from their prize winnings, and they should seek independent financial advice prior to acceptance of their prize(s). The Promoter accepts no responsibility for any tax implications that may arise from accepting a prize. Entrants are responsible for any and all expenses that they incur in entering the competition and they will not be reimbursed regardless of whether or not they win the competition.
9. The time of entry will be deemed to be the time the entry is received by the Promoter.
10. Entrants may submit up to the Maximum number of entries as stated in Schedule.
11. The notification will include details about how the prize(s) can be claimed.
13. The Promoter takes no responsibility where it is unable to contact prize winners who have not provided correct or complete contact details. If an entrant's contact details change during the Competition period, it is the entrant's responsibility to notify the Promoter. A request to modify any entry information should be directed to Promoter.
14. It is a condition of accepting any prize that the winner must comply with all the conditions of use of the prize and the prize supplier's requirements. Each prize must be taken as stated and no compensation will be payable if a winner is unable to use the prize as stated.
15. The winner(s) name will be published in accordance with the public announcement of winners' section of the Schedule (if applicable).

Entrants accept all risks in participating in the Competition and will not hold the Promoter (including its officers, employees and agents), liable for any damage to property, personal injury or death incurred in connection with participating in the Competition, whether arising in negligence or otherwise.

17. To the full extent permitted by law, the Promoter excludes all warranties, representations or guarantees (Warranties) regarding the Competition and any prizes, including any Warranties which may have been made in the course of advertising or promoting the Competition. The conduct of the Competition or the supply of prizes may involve third parties, and the Promoter makes no Warranties and disclaims all liability in connection with any such third parties, their acts or omissions. Without limiting any of the foregoing, in no circumstances will an entrant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.
20. The Promoter and its associated agencies and companies will not be liable for any delay, damage, or loss in transit of prizes.
21. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Competition at any time without giving reasons and without liability to any entrants, subject to any written directions from a regulatory authority. Without limiting this the Promoter reserves the right to verify the validity of entries, prize claims and entrants and to disqualify any entrant who submits an entry or prize claim that is misleading or not in accordance with these Terms of entry or who manipulates or tampers with the entry process. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter including third parties may, for an indefinite period, unless otherwise advised, use the private information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant.
26. The collection and disclosure of personal information provided in connection with this Competition will be handled in accordance with the Promoter's Privacy statement which adheres to the Privacy Act 1988 (Cth) and Australian Privacy Principles.
27. The Competition and these Terms of entry will be governed by the law of the Northern Territory. Entrants accept the exclusive jurisdiction of courts and tribunals of the Northern Territory in connection with disputes concerning the Competition.
