## **Terms and Conditions of Entry**

1. These Terms and Conditions of Entry incorporate the Schedule. If there is any inconsistency between the Schedule and these Terms and Conditions of Entry, the Terms and Conditions of Entry prevail.
2. Participation in this Competition is deemed acceptance of these Terms and Conditions of Entry. Entrants not complying with these Terms and Conditions of Entry are ineligible entrants and the Promoter reserves its absolute right to disqualify any entrant from the Competition if any entries do not comply with the Terms and Conditions of Entry.
3. Entry is open to any person who meets the requirements of these Terms and Conditions of Entry.
4. The Competition will be conducted during the Competition period as stated in the Schedule.
5. The Prize/s are as specified in the Schedule.
6. The total prize pool is as specified in Schedule.
7. Any prize is valued in Australian dollars unless expressly stated to the contrary.

23. The Promoter and its associated agencies and companies will not be liable for any delay, damage, or loss in transit of prizes.
24. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Competition at any time without giving reasons and without liability to any entrants, subject to any written directions from a regulatory authority. Entrants consent to the Promoter using the personal information provided in connection with this Competition for the purposes of facilitating the conduct of the Competition and awarding any prizes, including to third parties involved in the Competition and any relevant authorities. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter including third parties may, for an indefinite period, unless otherwise advised, use the private information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant.
