

1.1 Executive Overview As at 31 May 2015

RESULT

Operating Income

Operating income is currently at 97% for the full year.

Operating Expenditure

Overall operating expenditure increased to 88% in line with budget expectations.

Capital Income

All anticipated capital income items have been received for this financial year, actuals are showing at 100% for the year.

Capital Expenditure

Capital Expenditure year to date plus commitments increased by \$1.07M in this period. The percentage Capital expenditure for the year is now at 54.4%.

CASH POSITION

As at the end of May 2015 the cash and investments balance was \$26.1m. An investment of \$2M was due for maturity on 27th May 2015, however the redemption of funds has been delayed until 1st June 2015, this has been shown on the monthly investment report. As at 1 July 2014 reserve requirements with restricted access was \$33m. Interest earned to date was \$931k, circa 114% of budget.


