

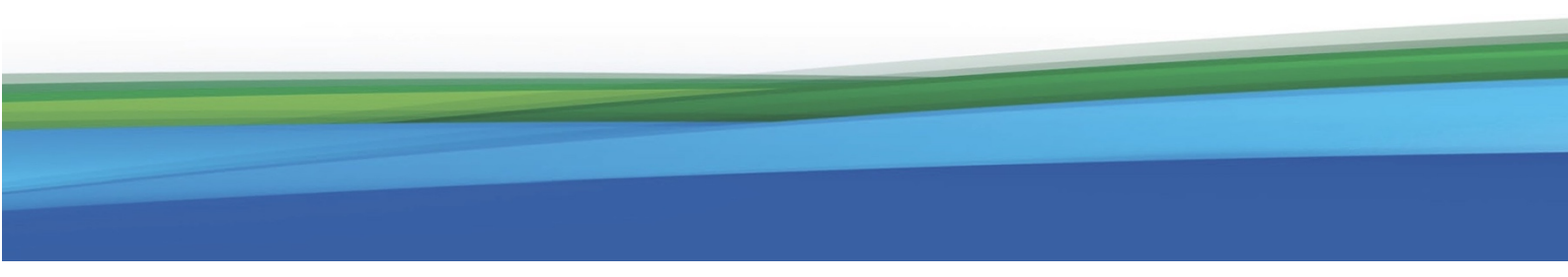

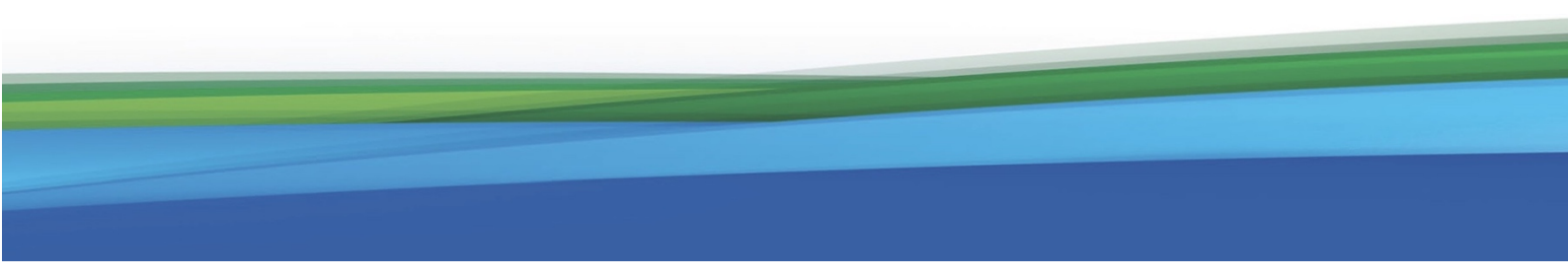

Summary:

Council has requested that opportunities for shade and to add colour and vibrancy to Goyder Square be explored. Discussions have been held on site with the lighting supplier RayLinc and a quotation sought for shading the water tower playground. To maintain the integrity of the original design, landscape architect Turf Design was requested to provide a proposal to provide recommendations for suitable shade and colour options. Turf Design has submitted a fee proposal of \$9,950 (ex GST) and will undertake a workshop with Council in early February 2017.

RECOMMENDATION

THAT Council receives Report Number 8/1064.

Background:

Council Decision 8/2269 requested in-part, a report be brought to the EDI Committee:

on current and potential shade options for Goyder Square, including implications and whole of life costings ...

Council Decision 8/2252 requested a report be brought to Council which:

Examines opportunities to add colour by way of lighting, flags, etc to existing features in and around Goyder Square

Council Decision 8/2300 approved proceeding with the feature lighting of the water tower.

Contractors advise that the water tower feature lighting is expected to be installed in February 2017. Other opportunities to add colour through lighting changes were discussed on site with the lighting supplier RayLinc. RayLinc suggested that it would be possible to place a coloured lens over the existing

LED lights however this would require a bespoke approach as there was no standard coloured fitting. RayLinc also suggested that rather than colour all lighting, a better effect would be achieved by picking a particular feature to highlight such as the water tower.

NT Shade a local company provided a quotation of approx. \$13, 400 (ex GST) for a basic shade structure over the children's playground at the water tower (**Attachment A**). This structure would be required to be removed each time a cyclone was approaching and was not considered in keeping with the design intent of Goyder Square.

To maintain the integrity of the original design of Goyder Square, the landscape architect Turf Design was requested to provide a proposal to provide recommendations for suitable shade and colour options for Goyder Square.

General:

Turf Design has submitted a fee proposal of \$9,950 (ex GST) (**Attachment B**) to provide advice on opportunities for enhancing shade and colour in Goyder Square and the city centre. Turf Design propose to:

- undertake a preliminary investigation of shade and colour options
- hold a workshop with Elected Members
- present a list of suitable permanent and temporary shade elements for consideration

It is expected that the site visit and workshop with Elected Members will be held in early February 2017.

Financial Implications:

The Turf Design proposal is costed at \$9,950 (ex GST).

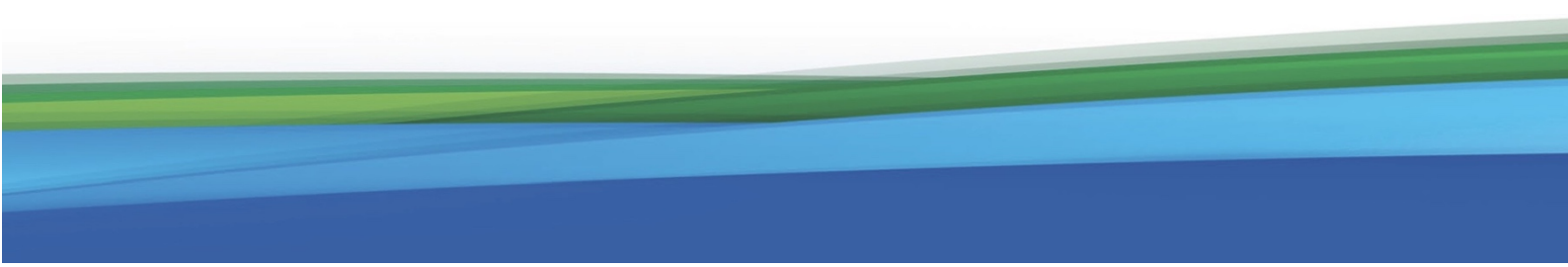

PALMERSTON WATER TOWER WOOLNOUGH PLACE, PALMERSTON NT



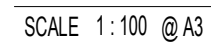

Background:

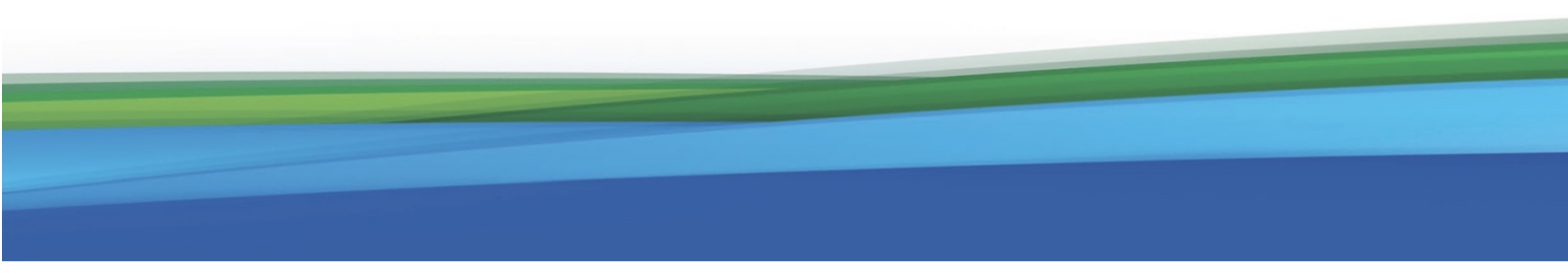

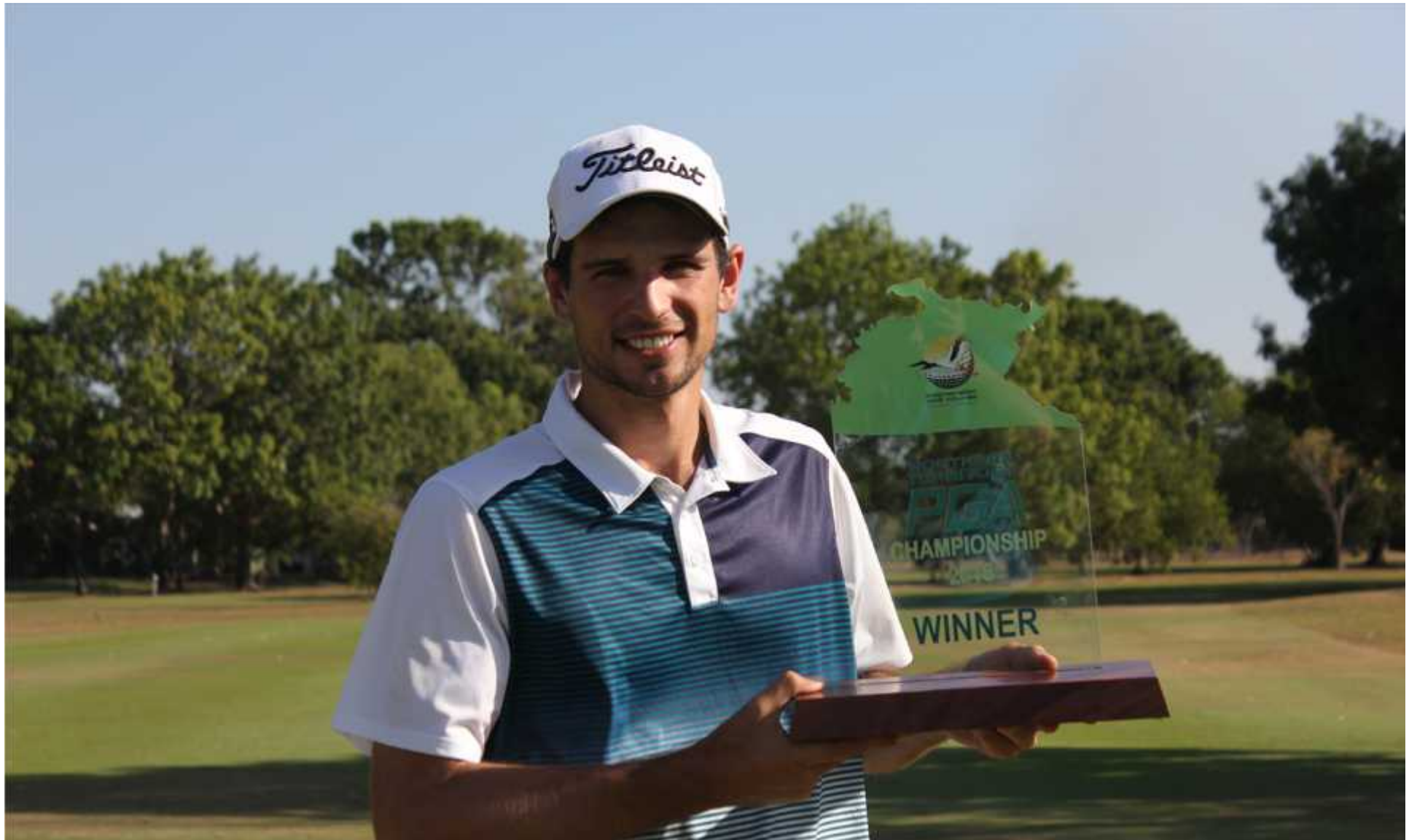

Summary:

This report provides an update of the Arts and Culture portfolio within Community Development.

RECOMMENDATION

THAT the Committee receives Report Number CCE/0413.

Background:

Art and culture is a valuable contributor to a flourishing, innovative and cohesive community. Council aims to contribute to a positive community and cultural identity for residents of Palmerston through facilitating, supporting and encouraging:

- an increase of artistic expression through a variety of mediums by a diverse range of community members;
- more opportunities to build community pride and the capacity of artists, community groups and residents;
- an increase of art and culture resources and the enhancement of places and spaces;
- the value of arts, culture and heritage in Palmerston; and
- partnerships with sector stakeholders.

General:

Below is a brief overview of current Arts and Culture initiatives and programs:

Voices of Palmerston

Voices of Palmerston is an evolving multi-arts, participatory project launched in 2017 capturing local stories and sharing them with a global audience via a website of the same name. The project captures segments and slices of the lives of people living, working or playing in Palmerston and displays them on the website. The website is currently under construction.

Voices of Palmerston was identified in the Palmerston Arts Strategy 2016 – 2021 as one of a number of tools to be used to achieve the Strategy outcomes. The objectives of Voices of Palmerston are:

1. To facilitate arts practice and community interaction during the process of capturing stories
2. To encourage and empower local people to share their story with their community
3. To provide a platform to store and share the captured stories
4. To celebrate the stories of Palmerston with their authors, story tellers and wider community
5. To create an archive of stories that will colour Palmerston via public art in the future

The project allows people to share their story using a variety of art mediums via artist facilitated workshops. Some workshops are targeted at specific community groups, and others are open to the public to attend if they wish. The project will also provide a platform whereby people can submit their story without having to participate in a workshop.

The pieces of art and the story behind the artwork, presented on the Voices of Palmerston website, will be a source of pride for the storyteller and will create an online canvas describing life in Palmerston to the rest of the world. It will also be an archive full of art and stories that may be used as a source of inspiration for temporary and permanent public art in the future.

SPUN: A Live Story Telling Event

SPUN: A Live Story Telling Event is being held in Palmerston on Saturday 3 June 2017 from 6 -8:30pm on the lawns of The Heights, Durack Community Centre. This is an exciting event for the people of Palmerston and expects to attract 200+ guests to listen to the true stories of six (6) Territorians.

SPUN showcases extraordinary locals and their stories. Popping up at different venues every three months, SPUN brings people from all walks of life together to share stories under a theme. The theme for the Palmerston event is 'Obsession', exploring how an interest can turn into an obsession and discovering at what lengths people go to for the things they love.

SPUN is run by a team of professionals who are passionate about oral storytelling. Every storyteller is matched with a story producer who helps bring out the best in their story. City of Palmerston are working with the team at SPUN to organise this free event presented for residents and visitors of Palmerston.

Community Development Outcomes:

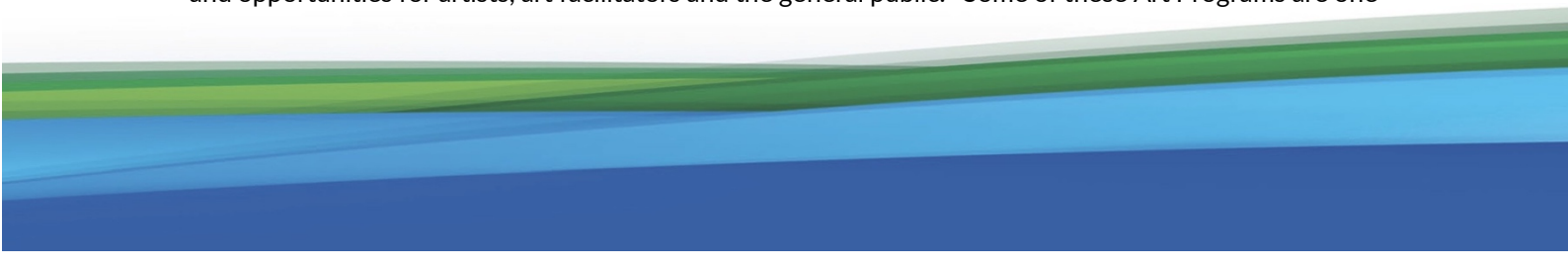
SPUN aims to celebrate local people, start conversations, shake things up and ultimately promote social cohesion through the sharing of personal stories.

SPUN does this by:

- Engaging a cross section of locals from diverse backgrounds, ages and stages
- Searching for 'untold stories' that might otherwise go unheard
- Curating a line-up of stories that surprise, challenge stereotypes and promote empathy
- Working with storytellers to enhance their storytelling skills so that the process is both empowering and entertaining
- Hosting events in locations that are accessible to a broad range of locals
- Reaching audiences who wouldn't normally attend an arts event

The Heights, Durack Community Centre

City of Palmerston is currently responsible for two (2) Art Workshop spaces at The Heights, Durack Community Centre. The Centre was launched by the City of Palmerston on 20 August 2016. Since then over twenty (20) Art Programs have been supported by City of Palmerston providing classes, workshops and opportunities for artists, art facilitators and the general public. Some of these Art Programs are one



off intensive style workshops, and others have been a series of classes running for often up to 8 weeks. The Art Programs have targeted a diverse range of Palmerston residents, providing access to the Arts to children, teenagers, seniors, migrants, mothers and more.

Additional art classes and workshops have been run during this time by established artists and art organisations that haven't required the organisational or subsidy support by Council. It is hoped this will continue to increase as the support Council is currently providing increases the capacity and confidence of local artists.

The Centre provides an avenue by which to support local artists; some of the programs and initiatives currently available to artists are:

Artists Craft and Tea: Free use of the Art Workshop Space one night a week for artists to meet, make connections, work on their practice and share some dinner.

Subsidies: Support provided to artists to run art classes or workshops at the Centre for the public. The subsidy reduces the cost of the Class or Workshop to the general public encouraging more people to attend and making the class/workshop more accessible.

Art Workshops: These are available for anyone to book via City of Palmerston's online booking system.

Financial Implications:

All programs are provided for within the current 2016/17 budget.

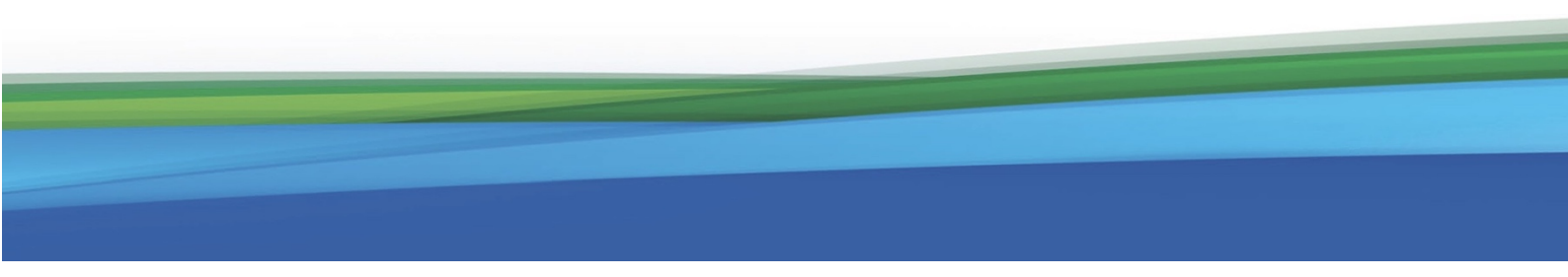

Summary:

This report provides an update of programs and events supporting culturally and linguistically diverse members of the Palmerston community. These initiatives also support City of Palmerston's commitment to be a Refugee Welcome Zone.

RECOMMENDATION

THAT the Committee receives Report Number CCE/0414.

Background:

People from a wide range of ethnic and cultural backgrounds call Palmerston home. According to the Australian Bureau of Statistics 2011 Census, 24.3% of people living in Palmerston were born overseas and 21.6% of people have both parents born overseas.

2016 saw the beginning of a reasonably large cohort of newly arrived Australians from refugee backgrounds being settled in various suburbs in Palmerston, mainly Johnston and Durack. This arrival and settlement is ongoing and expected to continue indefinitely. The majority of people are from Syria, Iraq and the Congo and most have suffered trauma and/or torture either from their countries of birth or during their journey to Australia.

In 2013, City of Palmerston signed a Declaration committing to be a Refugee Welcome Zone. A Refugee Welcome Zone is a Local Government area which has made a commitment to welcoming refugees into the community, demonstrating compassion, contributing to upholding the human rights of refugees and encouraging and enhancing cultural diversity in the community.

General:

Below is an update describing some of the programs and initiatives providing support to people from a refugee and culturally and linguistically diverse background.

Harmony Day Family Festival

Harmony Day is an Australian Government program held annually on 21 March. The message of Harmony day is that everyone belongs; it is a day of cultural respect and celebration. For the third year, City of Palmerston has supported a broad community event via the facilitation of a working group, to organise a Harmony Day Family Festival. It was held at the Gray Football Stadium, kindly hosted by the Palmerston Football Club, on Saturday 1 April from 3 – 9pm.

The Festival changed its name in 2017 from a 'Football' to a 'Family' Festival to encourage attendance by a broader cross section of the community. This was successful with attendance at the event increasing considerably from the previous two years. Being an event held over six (6) hours, where people came and went throughout the day, it is hard to accurately determine attendance numbers but a conservative estimate is 500-600 people with about 200 people directly involved in the activities on the day, i.e. footballers, performers, artists, etc.

A Festival Working Group re-formed in January 2017 to jointly plan, organise and implement the event. It was made-up of volunteer community members, service providers and sporting group representatives and was facilitated by City of Palmerston's Community Development Officer. This group has grown in numbers, strength, diversity and capability over the three years that this Festival has been run.

The Festival is focused on football (soccer) matches. Sport is a well-practiced avenue for breaking down barriers and creating friendships, pride and purpose; and football has a connection to more cultures, languages and ethnicities than any other sport globally. This year saw an increase of football matches from three (3) to four (4):


- Football without Borders V Palmerston Football Club
- Congolese Community V Darwin Hearts Club (Nepalese)
- Darwin Hellenic (Greek) V Casuarina Football Club (Timorese and Portuguese) – Women's Match
- African Community All Stars V Darwin Shamrocks (Irish)

This year also saw the Festival incorporate nine (9) Cultural Performances including solo singers, bands, dancers, and traditional performance groups. The performances were very well received creating an atmosphere of celebration and fun.

A 'Harmony Place' was created that was well attended throughout the day. Families could take part in an Origami art activity run by Darwin Community Arts, a 'story capturing' exercise run by Artback NT or receive advice and information from service providers, educational institutes and other community interest groups.

The No More to Family Violence Campaign was a major contributor to organising and supporting the event with all players receiving a talk in the change rooms prior to each match followed by a linking arms in front of the audience as a symbol of their commitment to say No More to Family Violence.

The event was successful in involving, and increasing the capacity of, a variety of community groups and members; for example:

- A young Larrakia man, Richard Fejo Jnr, performed the Welcome to Country with guidance and support from his Father.
 - A Congolese woman, Carine Kapiamba, was engaged as Master of Ceremonies.
 - Four members of Youth in Palmerston (YIP), who had recently completed public speaking training, assisted in the MC duties, providing them with an opportunity to practise their training.
 - Nine Cultural Performance groups were provided the opportunity to share their culture and performance in front of a considerable audience.
- 

There was food, drinks, kids face painting, jumping castle, water slide and art activities. St John's Ambulance provided their volunteer services.

Community Development Outcomes:

- Increased the capacity of community groups to organise and hold events
- Facilitated positive relationships between community groups and Council
- Strengthened relationship with stakeholders encouraging them to provide more services to the Palmerston community.
- Palmerston residents had the opportunity to participate in a positive event promoting family and community harmony
- Increased awareness of Harmony Day and No More to Family Violence messages within the Palmerston community
- Increased interaction and engagement between community groups and residents from different socio economic and ethnic backgrounds
- Strengthening of Councils commitment as a Refugee Welcome Zone.

Palmerston Migrant Reference and Advisory Group

This Group was formed in November 2016 and has since held monthly meetings attracting a healthy attendance of between 8 – 16 people. The Group is facilitated and supported by Melaleuca Refugee Centre, Red Cross and the Multicultural Centre of the NT and is attended by representative(s) of the:

- Community Development Team at City of Palmerston
- Anglicare NT
- NT Police
- Irish Community
- Congolese Community
- NT Thai Association
- Vietnamese Community
- Islamic Society of Palmerston
- Syrian Community
- Liberian Community
- African Community
- Karen Community
- NT Government MLAs
- Other interested community service groups, schools and community members.

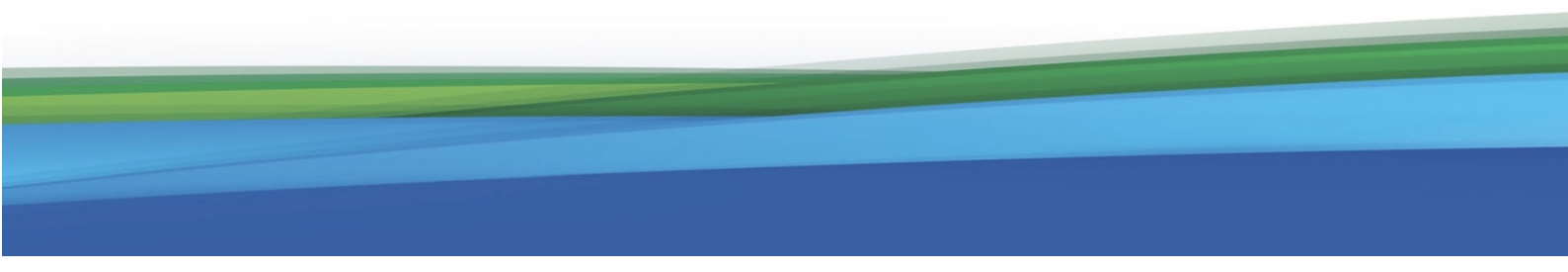
The Group aims to identify shortfalls in services to culturally and linguistically diverse (CAML) communities in the Palmerston region and commits to work with these communities along with service providers, NT Government and City of Palmerston toward generating solutions.

The Group also aims to generate a newsletter providing easier access for service providers, Government and Council to deliver programs and initiatives aimed at the CALD community, many of whom experience isolation and unintentional segregation.

Our Common Threads in Palmerston

Our Common Threads is an Arts Therapy initiative whereby art/craft/textiles are used to develop a social support and friendship group for mothers and children living in Palmerston.

This program was run in November, December 2016 and January 2017 with the target group being Mothers from a different cultural background raising children in Palmerston, i.e. those from a refugee and CALD background. The aim was for Mothers to meet others similar to them, and feel supported living and raising children in Palmerston and for their children to gain confidence to make friends and be happy living in Palmerston.



The program was held in the art workshop space at The Heights, Durack Community Centre; and provided an artist on one side of the Workshop facilitating and supporting the Mothers, and a second artist on the other side of the Workshop entertaining the children – allowing the Mothers the space and time to form connections and receive support. There was also transport, additional childcare, and counselling provided by Melaleuca Refugee Centre.

The program was extremely successful with attendance by those newly arrived Australians being settled in Palmerston, as well as migrant Mothers who have been living here for a number of years and women from the broader Palmerston community who wanted to meet and help people from a refugee background.

Due to the success of the first program, and in response to requests from the attendees and service providers, it has been determined to run a second program of Our Common Threads in Palmerston from late April until early July. This second program has been broadened to target all Mothers and their Children living in Palmerston who need friendship, support and social connections.

New Resident Guide

To help newly arrived Australians and migrants settle into Palmerston, the 'Living in Palmerston Guide' has been translated into French, Farsi and Arabic. These languages were chosen after consultation with Melaleuca Refugee Centre and the Multicultural Centre of the NT, along with analysis of data advising on recent migrants to Palmerston according to Australian Bureau of Statistics 2011 Census.

The translated New Resident Guides are published on the City of Palmerston website, and have been distributed via appropriate service providers such as Anglicare NT and Melaleuca Refugee Centre.

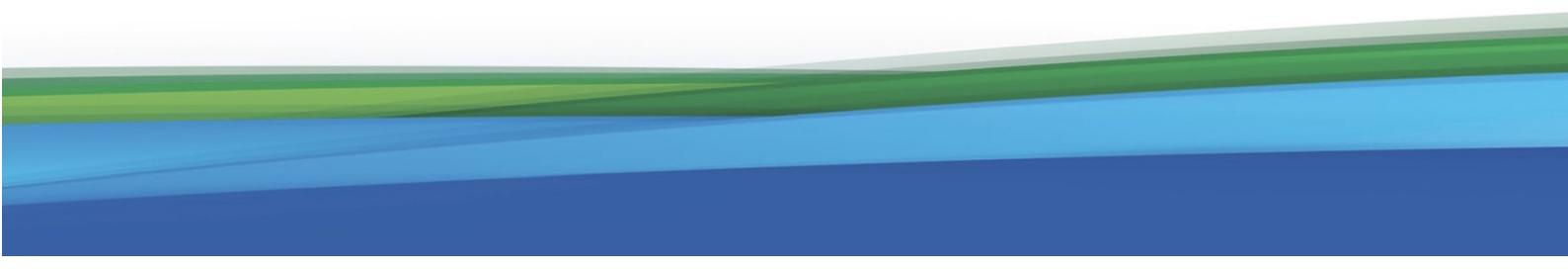

Background:

Harvest Corner Community Garden was established in 2014 with funding and assistance from the City of Palmerston. Since then the garden has become incorporated, with its own volunteer committee and membership base. Harvest Corner continues to partner with City of Palmerston on many of their community events as well as partnering with many local organisations and schools. The Garden is interested in brightening their space and involving more of the community in their programs and initiatives.

General:

Harvest Corner have expressed that they would like to paint a mural on the external wall of Gray Hall, adjoining the garden. No funding is requested as Bunnings Palmerston has offered to fund the project through their community initiatives, with YMCA Back to School Program students assisting with the project.

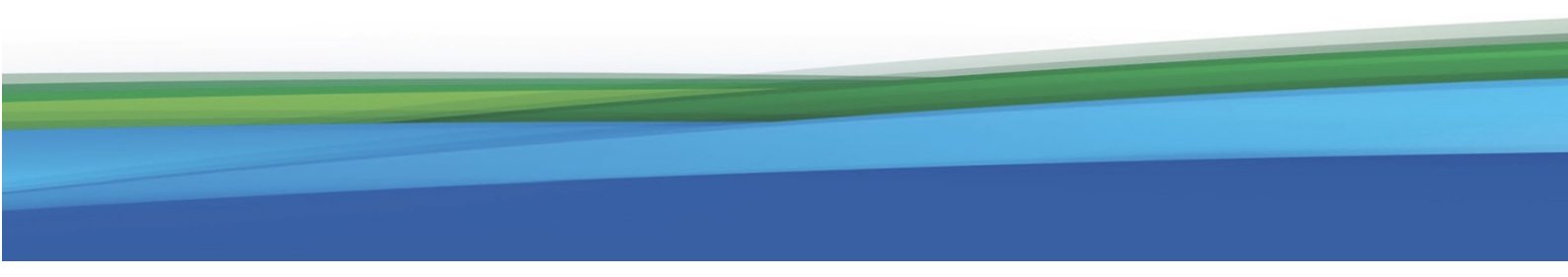

We write to request Council's permission to paint an external wall of Gray Community Hall that interfaces with Harvest Corner Community Garden.

As you well know, Harvest Corner Community Garden was established in 2014 with funding and assistance from City of Palmerston and we still maintain an ongoing partnership with CoP which is highly valued. The Garden is now managed by a volunteer committee and has both grown membership and achieved financial independence.

We feel that this project will enhance the attractiveness of the garden, give the students an opportunity to spend time doing an outdoor activity and build a greater connection with local residents. The project will be funded by Bunnings Palmerston as one of their community initiatives. The Committee are happy to agree with any policies or guidelines that the Council may have around public artwork.

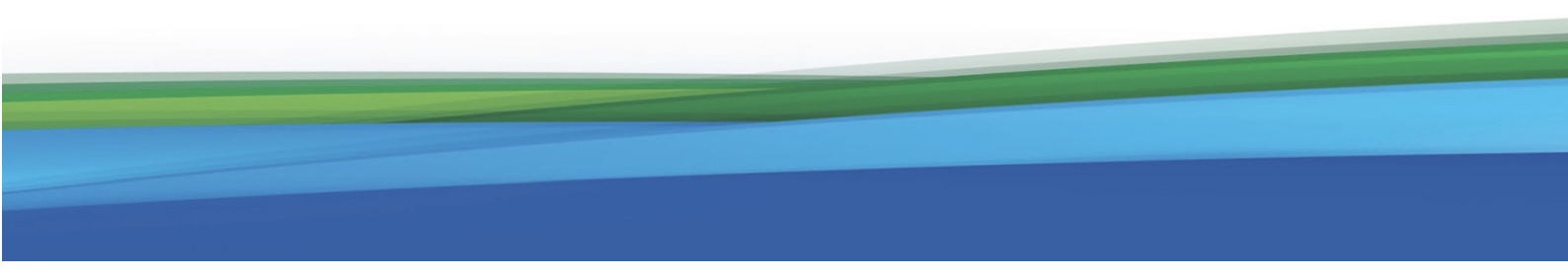

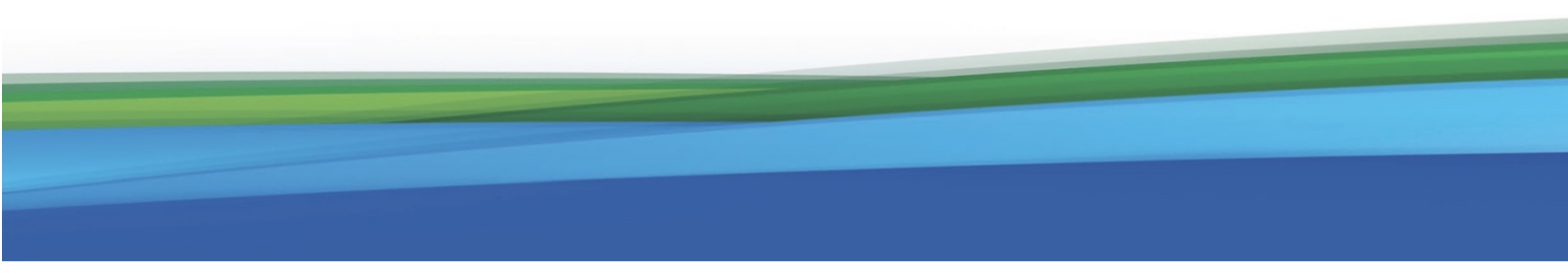
