PURPOSE

This report seeks to inform the Palmerston Safe Communities Committee on the progress of the Palmerston and Rural Youth Services (PaRYS) network.

KEY MESSAGES

- PaRYS members provided updates on local events, initiatives, and support services available in Palmerston.

BACKGROUND

Palmerston and Rural Youth Services is held every six to eight weeks with stakeholders working together to provide services to young people in Palmerston. This report provides an update on the Network.

DISCUSSION

Palmerston and Rural Youth Services Network (PaRYS) members met on Tuesday 1 December 2020. Network members shared information regarding several projects being rolled out across the sector:

- School Holiday Calendar (December 2020 January 2021)
- PaRYS Network Resilience and Capacity Building Session
- Palmerston Youth Information Map

The Northern Territory Government launched its Palmerston School Holiday Program for December to January 2020/21. The program is supported by YMCA, Larrakia Nation, Palmerston and Regional Basketball Association and City of Palmerston. All activities are free, and the calendar is available on youth.nt.gov.au.

City of Palmerston provided a professional development opportunity entitled *Reset* for members of the PaRYS network, focusing on resilience and capacity building within the youth services sector. The session

was held at the Palmerston Recreation Centre on 15 December 2020 with 30 attendees. The session was facilitated by Amy Hetherington. These encouraged team building between members of the youth sector as well as strategies for engaging with young people with interactive games.

The new *Palmy Youth Info Map* has been printed and delivered to locations around Palmerston. The resource was created to support the connection of young people to services and safe spaces. It highlights a range of services and how young people can get in contact with them. This project was funded by Northern Territory Government and supported by City of Palmerston.

BACKGROUND

The PSCC is held six times a year and works towards achieving a safer community. This report provides an update on the action items and recommendations taken from previous meetings.

DISCUSSION

Updates are provided on the actions arising from previous PSCC meetings:

Transport Activity Plan

Action: Discu

Discuss a transport activity survey with Department Infrastructure, Planning and Logistics (DIPL) to inform the plan for improving the bus network connectivity in Palmerston. Director City Growth and Operations met with Passenger Transport (DIPL) senior staff to discuss bus network connectivity in Palmerston and to enquire about a Strategic Plan regarding the network connectivity and the potential to conduct a transport activity survey to inform the Plan.

It was confirmed there is no Strategic Plan being developed, however as part of considerations in the relocation of the Darwin Bus Interchange, various aspects of public transport operations were being considered such as scheduling, connectivity, and frequency. These considerations will have a flow on impact to Palmerston.

Passenger Transport advised if Council wishes to undertake a transport activity survey, DIPL will provide some assistance in the drafting of survey questions. They will also engage with Council to discuss matters relating to public transport such as service improvements, future growth, the planning of infrastructure and routes of travel.

Update:

Council staff are in the process of preparing a letter to the Minister for Infrastructure, Planning and Logistics to request information regarding the Darwin Regional Transport Plan Action items in relation to improvements to frequency, span of service and timetabling for future discussion with Council.

Shock Therapy Productions

Action: In response to rock throwing, an update will be provided back to the Committee on how

it can support a performance of the Shock Therapy Productions play called "The

Stones" at schools in Palmerston.

Update: Council regularly supports and celebrates cultural and live theatre events each year as

part of our community event programming. A performance by Shock Therapy Productions will be considered when reviewing suitable artists to perform at future Council events. The performance would be made accessible by the entire Palmerston

community.






