COMMUNITY PLAN

Family and Community: Palmerston is a safe and family friendly community where everyone belongs.

PURPOSE

This report seeks to inform the Palmerston Safe Communities Committee on the progress of the Palmerston and Rural Youth Services (PaRYS) network.

KEY MESSAGES

- The Palmerston and Rural Youth Services network met on 27 April 2021.
- The next meeting will be held on 8 May 2021 at the Palmerston Recreation Centre.
- Network members provided updates on local events, initiatives, and support services available in Palmerston to young people aged 12 to 25 years.

RECOMMENDATION

BACKGROUND

Palmerston and Rural Youth Services Network (PaRYS) is held every six to eight weeks with stakeholders working together to provide services to young people in Palmerston. This report provides an update on the Network.

DISCUSSION

PaRYS members met on Tuesday 27 April 2021. The following items were discussed by the Network:

- Palmerston Youth Action Plan
- NT Youth Voice
- Urban Jams Event
- Youth Programs and Opportunities

The Urban Jams event held in Goyder Square on 10 April 2021 attracted over 475 participants. The free event provided opportunities for engagement between members of the public and local services providers. The review of the Palmerston Youth Action Plan was launched at Urban Jams with development underway for the new plan for the Palmerston region.

The Northern Territory Council of Social Service (NTCOSS) received funding from the Federal Government to deliver a Youth Advocacy program across the Northern Territory (Youth Voice NT). This will include raising the profile of issues impacting young people and the youth sector in the NT. In addition to building the capacity of the youth sector through the facilitation of training opportunities; promoting good stories about young people and sharing information and resources; and identifying mechanisms that will improve young people's engagement with Government on issues and initiatives impacting them. NTCOSS is establishing the Youth Voice NT Steering Committee, which will be made up of young people and youth sector representatives who can represent young people. NTCOSS is seeking expressions of interest from those interested in being involved in the program.

King and Queen of the North is the first of its kind in the Northern Territory. The event is hosted by Northern Breaking Collective and the Australian Breaking Association. This competitive series of events will contribute to national ranking towards the Paris 2024 Olympics. The event is being held on 22 May 2021. More details can be found at palmerston.nt.gov.au.

The next PaRYS meeting will be held on 8 May 2021.

COMMUNITY PLAN

PURPOSE

This report seeks to inform the Palmerston Safe Communities Committee (PSCC) on the progress of previous actions.

KEY MESSAGES

- The Department of Infrastructure, Planning and Logistics (Public Transport) has provided an update on improvements to the bus services within the Palmerston area.

BACKGROUND

The Palmerston Safe Communities Committee (PSCC) is held six times a year and works towards achieving a safer community. This report provides an update on the action items and recommendations taken from previous meetings.

DISCUSSION

Updates are provided on the actions arising from previous PSCC meetings:

Transport Activity Plan

Action: Discuss a transport activity survey with Department Infrastructure, Planning and Logistics (DIPL) to inform the plan for improving the bus network connectivity in Palmerston. Director City Growth and Operations met with Passenger Transport (DIPL) senior staff to discuss bus network connectivity in Palmerston and to enquire about a Strategic Plan regarding the network connectivity and the potential to conduct a transport activity survey to inform the Plan.

It was confirmed there is no Strategic Plan being developed, however as part of considerations in the relocation of the Darwin Bus Interchange, various aspects of public transport operations were being considered such as scheduling, connectivity, and frequency. These considerations will have a flow on impact to Palmerston.

Passenger Transport advised if Council wishes to undertake a transport activity survey, DIPL will provide some assistance in the drafting of survey questions. They will also engage with Council to discuss matters relating to public transport such as service improvements, future growth, the planning of infrastructure and routes of travel.

Update: The Department of Infrastructure, Planning and Logistics (Public Transport) recently advised City of Palmerston of two planned upgrades to the Palmerston bus network.

Route 74 – A deviation within Zuccoli, travelling via Tuckeroo Boulevard and Peaflower Street on Saturday and Sunday only commenced on Saturday 1 May 2021. The timetable has also been adjusted to improve the connection to Routes 8 and 9 at Palmerston Bus Interchange.

Route 87 – An extension of the route within Durack Heights is being investigated however this is experiencing delays due to the limited turn around points within the suburb. Public Transport has engaged City of Palmerston to explore possibilities for upgrades to the area and explore options for installation of bus stops.

Public Transport advised that community consultation will be engaged when required, and the scope of consultation will be based on changes to or planned infrastructure or changes to existing services that may impact the community.


